

# Athletes Elevator – Terms and Conditions

These Terms and Conditions govern your access to and use of the Athletes Elevator platform, operated by **Triangle for Events and Exhibitions Management**, registered and licensed in the State of Kuwait.

By accessing or using the Platform, you accept and agree to be bound by these Terms.

## 1. Eligibility & Verification

- Athletes of any nationality or background may register.
  - **Athletes under the age of 21** must provide:
    - Government-issued ID/passport
    - Legal guardian information and consent
    - Guardian's signature on any binding agreement
    - Optional selfie or video verification for identity confirmation
  - **Athletes under 18 are not permitted** to register.
- 

## 2. Account Types

### A. Athlete Accounts

- **Free Listing (0 KWD):**
  - Create a profile
  - Upload 1 highlight video
  - Basic visibility to scouts and clubs

- **Premium Listing (10 KWD – One-Time Payment):**

- Boosted search visibility
- Priority exposure in scout filters

## **B. Scout/Club/Academy Accounts**

- Must be verified and approved by the Athletes Elevator team.
- **Subscription Options:**
  - Monthly: 30 KWD
  - 3-Month: 75 KWD
  - Annual: 240 KWD
- Scouts remain **anonymous** to athletes until they initiate any of the following actions:
  - Trial Request
  - Invitation to Kuwait
  - Match Footage Request
  - Interview Request
  - Performance Report Request
  - Medical Check Request
  - Training Session Request

## **3. Talent Identification & Representation Contract**

- Athletes Elevator reserves the right to identify and approach high-potential players for direct representation.

- If selected, the athlete (and their guardian if under 21) will be offered a **Representation & Commission Agreement**, outlining:
    - Athletes Elevator's right to represent the player in negotiations
    - A **10% commission on the player's first-year salary** of any professional contract signed as a result of the platform
    - A **10% commission on any signing bonus**
  - Signing this contract is optional but required for Athletes Elevator to actively assist or promote the athlete to clubs, agents, or scouts.

#### 4. Highlight Video Policy

- Each athlete may upload **1 highlight video** (length and format subject to platform guidelines).
  - Video must be:
    - Accurate, unedited to mislead
    - Free of third-party ads or unrelated branding
    - Compliant with community guidelines
- 

#### 5. Platform Use & Code of Conduct

- Users must not:
  - Impersonate others or provide false information
  - Upload harmful, offensive, or copyrighted content
  - Communicate with others outside the platform for recruitment purposes without triggering an official action

- Athletes Elevator reserves the right to suspend or terminate accounts that violate these terms.

## 6. Payments & Refund Policy

- Payments for subscriptions and premium listings are **non-refundable**, except in cases of system error.
  - Payment is securely processed through authorized payment providers.
- 

## 7. Privacy & Data Protection

- All personal and performance data is securely stored.
  - Athletes Elevator does **not** sell or share data with external advertisers.
  - Data may be used internally to improve matchmaking, ranking, and system performance.

## 8. Scout Anonymity & Interaction

- Scouts are anonymous until they take official action.
  - Once action is taken, athletes will be notified through platform alerts.
  - Athletes may not message scouts directly unless invited.

## 9. Legal Jurisdiction

- All contracts and disputes are governed by the laws of the **State of Kuwait**.
- Athletes Elevator is a brand under **Triangle for Events and Exhibitions Management**, with full commercial licensing.
